## SUMMARY ANNUAL REPORT

For

### Alaska United Food and Commercial Workers Health and Welfare Trust

This is a summary of the annual report for the Alaska United Food & Commercial Workers Health and Welfare Trust, (Employer Identification No. 92-6003453, Plan No. 501) for the period January 1, 2018 to December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Insurance Information

The plan has contracts with The Union Labor Life Insurance Company, United of Omaha Life Insurance Company and Vision Service Plan to pay vision, life insurance, stop loss and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2018 were \$1,626,197 (1,520,400+19,845+85,952).

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2018, the premiums paid under such "experience-rated" contracts were \$85,952 and the total of all benefit claims paid under these contracts during the plan year was \$78,495.

#### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$276,194 as of December 31, 2018 compare to \$-1,981,072 as of January 1, 2018. During the plan year the plan experienced an increase in its assets of \$2,257,266. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$23,226,868. This income included employer contributions of \$20,886,444, employee contributions of \$2,007,001 and earnings from investments of \$73,322. Plan expenses were \$20,969,602. These expenses included \$1,857,798 in administrative expenses and \$19,111,804 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
